OPEN LETTER FROM ARIZONA BUSINESS, FAITH AND COMMUNITY LEADERSHIP

February 23, 2024

Dear Governor Katie Hobbs, Speaker Ben Toma and Senate President Warren Peterson:

We, the undersigned business, faith, and community leaders, come together to express our strong opposition to HCR 2060 and the Arizona Invasion Act (House Bill 2748, SB 1231). We can all agree that our current immigration system is broken. Here in Arizona, we need real solutions, not fear mongering and scapegoating of immigrants — the continued easy and vulnerable target in an election year.

Both proposals are turbo-charged versions of AZ SB 1070 or "show me your papers" law that passed in 2010. SB 1070 undermined Arizonans' public safety, destroyed our reputation, and deteriorated our economy as businesses and conventions boycotted the state for its anti-immigrant climate. Our state incurred a loss of \$141 million after SB1070's enactment in 2010, with a rippling loss of 2,761 jobs, \$86.5 million loss in earnings, a \$253 million loss in economic output, and \$9.4 million loss in tax revenues to the state. It also severely damaged the relationship with Arizona's largest trading partner — Mexico. Arizona has seen this "movie" before, and it did not end well.

HCR 2060 and the Arizona Invasion Act will threaten every Arizonan's public safety and weaken the economy. Like SB 1070, these proposals will deputize local police and other officials to verify the immigration status of immigrants, and arrest and detain otherwise law-abiding immigrant workers as they drive to work, church, and their children to school. They will generate fear and erode trust between immigrants and local police. When immigrants are afraid to come forward to help and cooperate with police to solve crimes, it damages the safety of all Arizonans.

These anti-immigrant proposals will cause unnecessary disruption to the workforce. According to the U.S. Chamber of Commerce, there are <u>9.5 million job openings</u> and only 6.5 million unemployed workers, leaving a significant gap of nearly <u>3 million open jobs</u>. Arizona currently only has <u>71 available workers for every 100 open jobs</u>. This labor shortage and further workforce disruption will drive up inflation and underscores the importance of adopting policies that attract and integrate workers rather than deter them.

We need real solutions to our broken immigration system, not election-year scapegoating. Rather than political gamesmanship, we urge our elected leaders to support <u>legal work permits</u> for long-term immigrant contributors, and sensible border provisions advanced by our U.S. Senators Kyrsten Sinema and Mark Kelly.

Immigrants are <u>vital</u> to Arizona's economy. Immigrants constitute approximately one-sixth of Arizona's labor force, playing a vital role in bolstering the local economy through various means. Among their contributions, immigrants represent 22.7 percent of entrepreneurs, 19.1 percent of STEM workers, and 12.0 percent of nurses within the state. Immigrants in Arizona contribute a total of \$8.7 billion in taxes paid and possess a combined spending power of \$26.4 billion.

We urge you, our elected leaders, to commit to advancing policies that attract talent, promote innovation, and contribute to the prosperity of Arizona. Please say "NO" to HR 2060 and HB 2748. Election year scapegoating and fear mongering are bad for Arizona.
