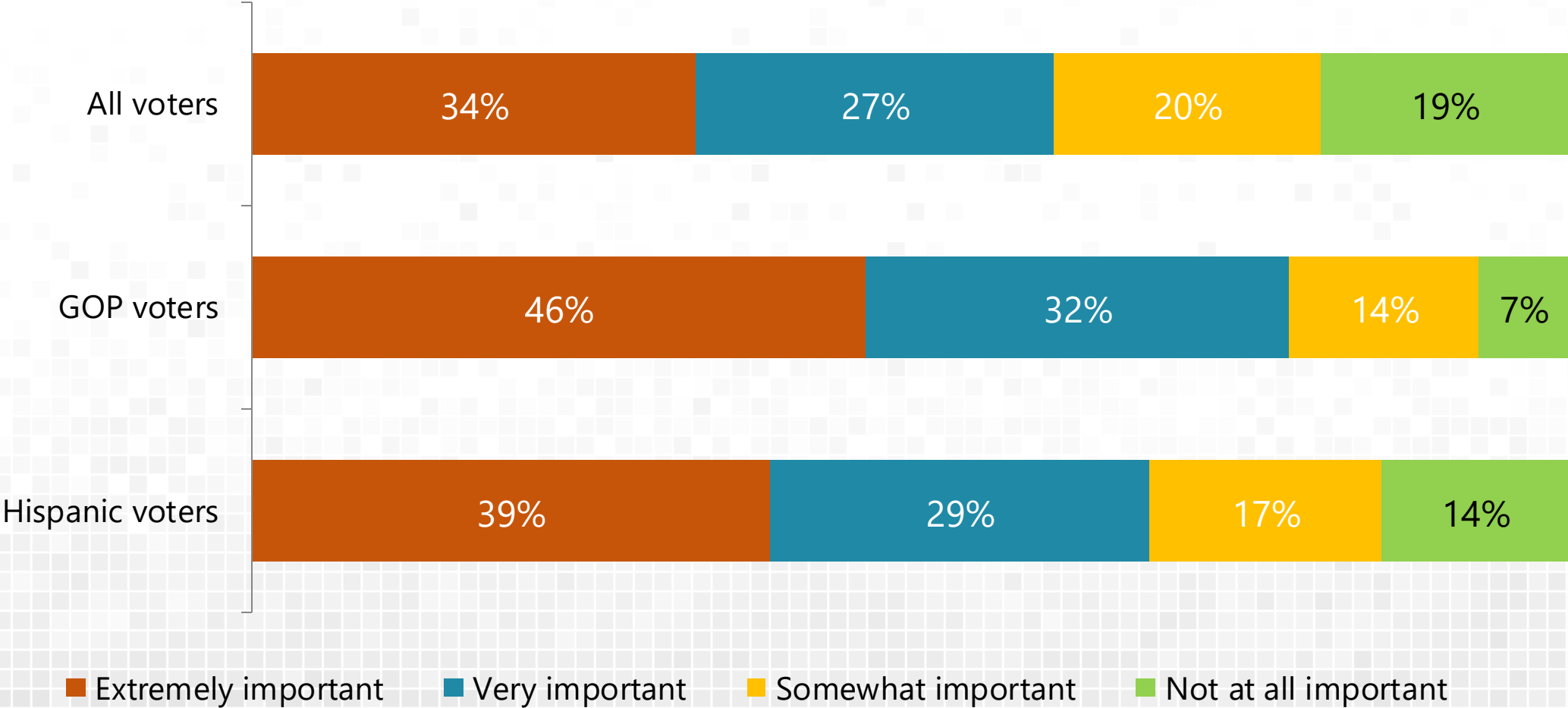
Field Dates: July 21-27, 2025

Total of N=270 interview among Hispanic/Latino voters in target states

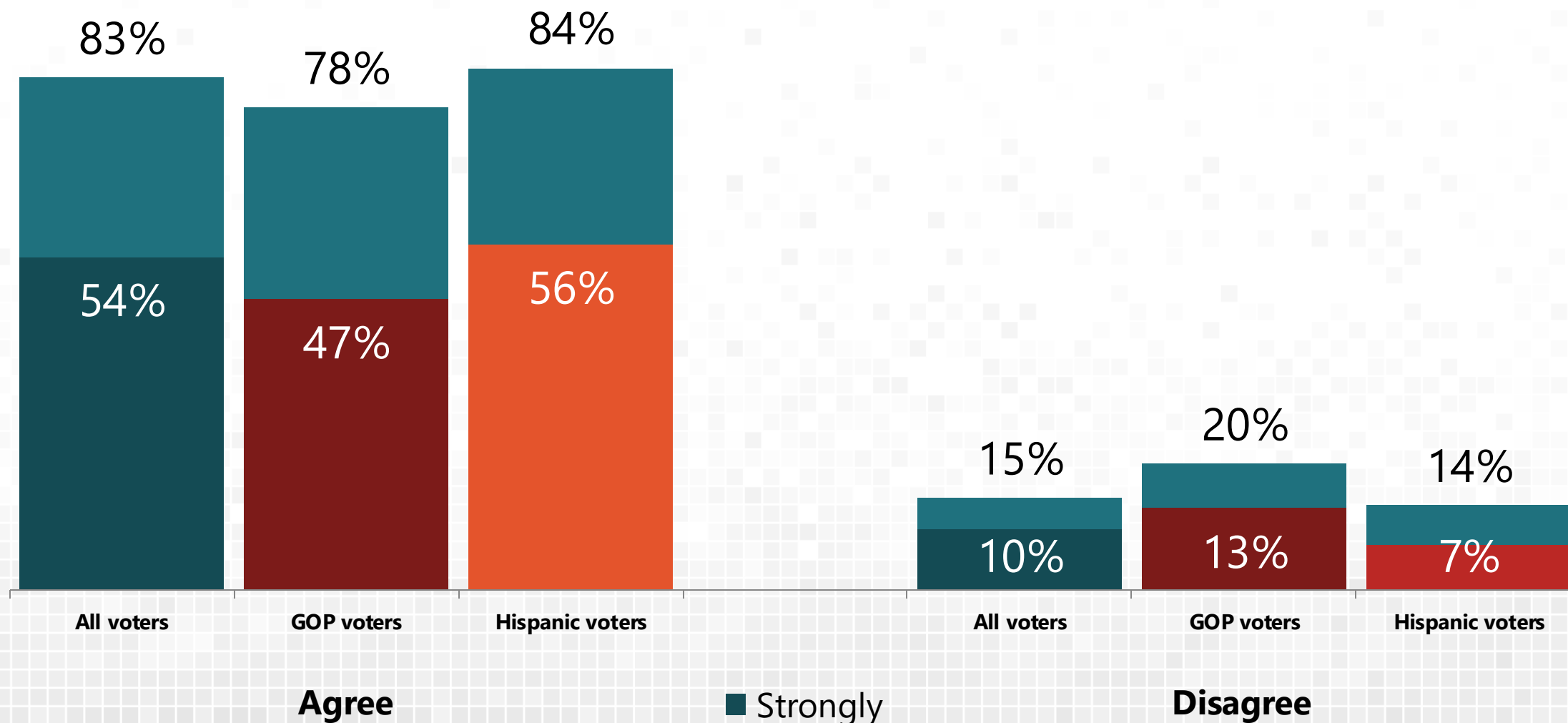

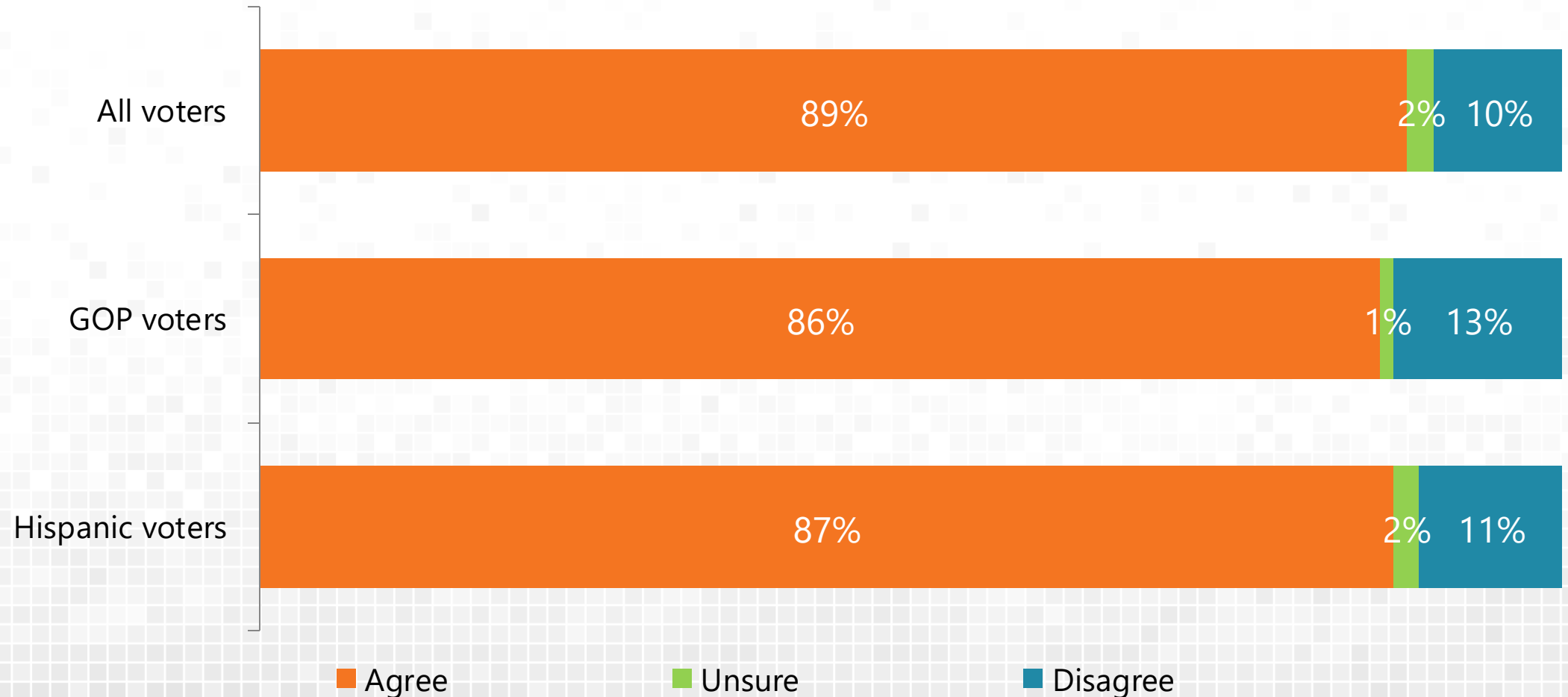

17. Congress needs to act now to create a work permit program for long-term undocumented workers who pay their taxes in order to stabilize our economy as the President mentioned.



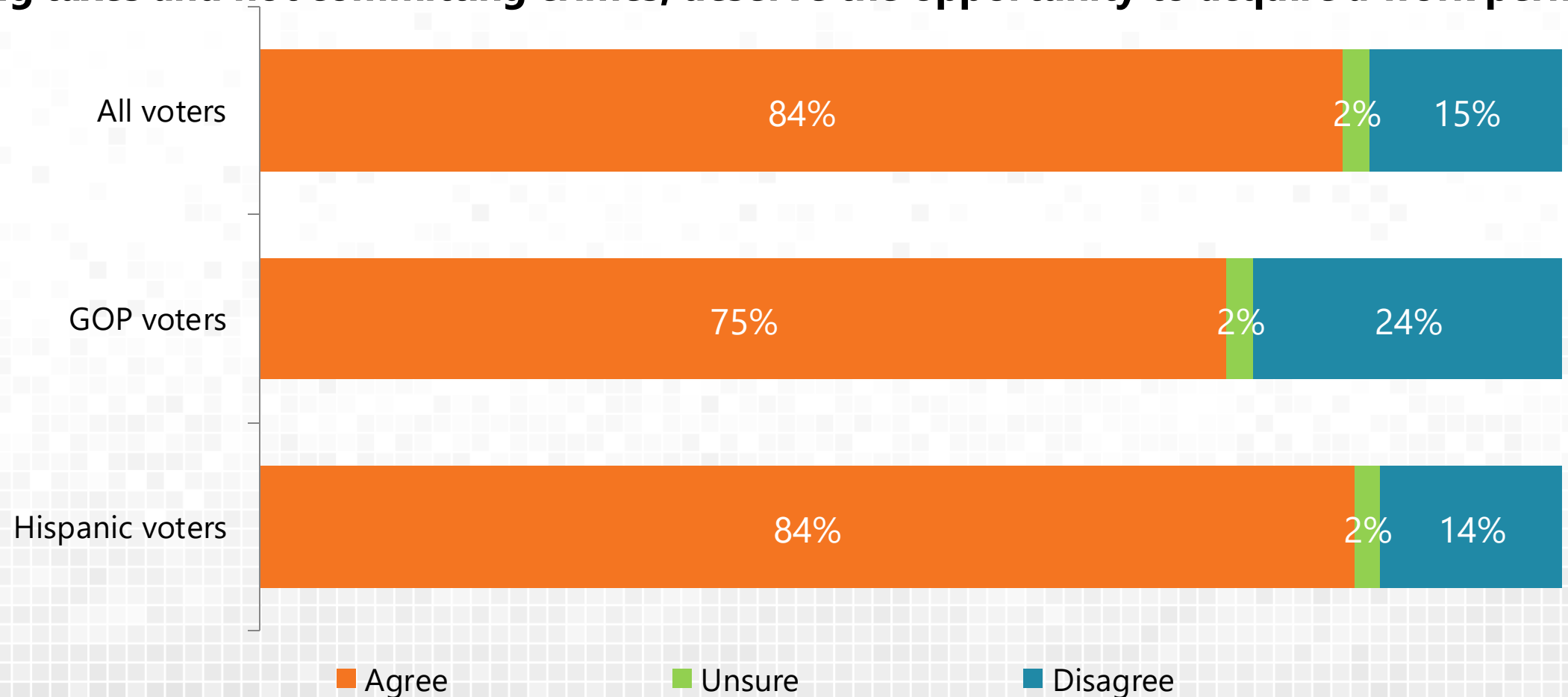

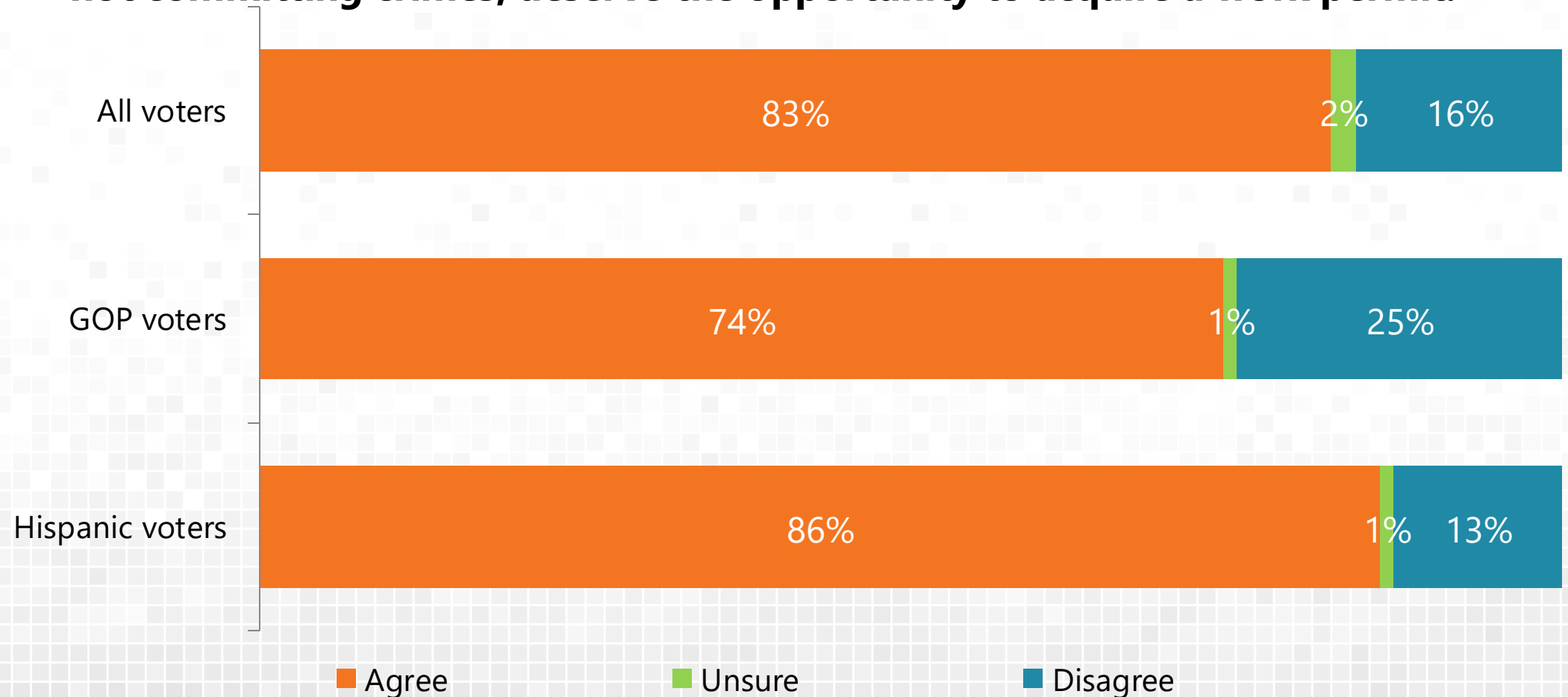
